## **PARTICIPANT Waiver and Release Form:**

In consideration of acceptance of my entry into the 2019 International Cat Show ("Event"), AKA "Cat- tacular, a special event sanctioned by The International Cat Association (TICA), I the undersigned, ("Participant") hereby:

1. Waive any and all rights I may have to inspect and/or approve such photographs, negatives, film/videotape and/or reproductions, any finished product relating thereto or the use to which it may be applied. I further agree that this Authorization and Release shall be binding on my heirs, successors, executors, administrators and assigns.

In connection with the subject matter hereof, ownership of any photographs, negatives, film/videotape and/or reproductions taken of me and/or my cat by or on behalf of Carson or its representatives, shall be vested in Carson, and I agree to release Carson and its representatives from any and all liability in connections therewith.
